- 4.4. Protect and maintain discretion with the confidential status of any information intended for only MHS and MHS-ratified club representatives.
- 4.5. Ensure thorough awareness and knowledge of all terms, policies, and procedures outlined in the MHS Club Agreement and as communicated by the MHS.
